Government Procurement Supervision

壹 採購稽核監督機制及分工

本會依政府採購法第108條之規定成立中央採購稽核小組,其任務在稽核監督機關辦理採購有無違反政府採購法令,期藉由稽核監督之手段,促使機關確實依政府採購法令辦理採購,俾建構公開、公平之採購環境。

内政部等14個附屬機關較多之部會署及25個地方政府成立採購稽核小組後,從中央到地方已建構較為完整之稽核監督體系,將有助於強化採購稽核監督機制及導正機關不當採購行為與減少採購缺失。

貳 採購稽核業務辦理情形

一、為導正不當採購行為,積極並持續透過 採購公報、公告及查核系統與媒體、民 意關切案件或廠商檢舉等管道,針對異 常採購進行稽核監督。為強化採購稽核 監督機制,協助及輔導其他39個採購稽 核小組積極辦理稽核監督作業並按月提 報稽核監督案件辦理情形一覽表,供本 會列管、統計、檢討及考核。另就其他 稽核小組稽核監督範圍之重大異常案件 會同稽核。本年度中央、部會署及地方 政府採購稽核小組分別稽核監督790 件、2,520件及5,464件,詳如附表。

I. Auditing Mechanism of Government Procurement Agencies

The PCC has established a Central Procurement Audit Unit in accordance with Article 108 of the Government Procurement Law. The unit's mission is to audit procurement by government agencies to assure that there is no violation of government procurement law and that the agencies carry out procurement in accordance with procurement law, thereby building up an open and fair procurement environment.

25 local governments along with 14 ministries, commissions, and administration, including the Ministry of the Interior, have set up procurement audit units, forming a complete auditing system. This system not only facilitates the reinforcement of the procurement auditing mechanism, but also rectifies the improper procurement behavior by government agencies, and deficiencies in government procurement.

II. Performance of Government Procurement Auditing

1. To correct improper procurement behavior, the PCC works vigorously and continuously through the government procurement gazette, announcement, and surveillance systems, the media, concerns expressed by elected representatives, and tips provided by companies to audit abnormal procurement behavior. The PCC also works to reinforce the auditing mechanism by helping and guiding the other 39 Government Procurement Auditing Units in implementing auditing operations and in submitting monthly reports on the performance of cases under their audit, so that the PCC will be able to carry out monitoring, statistical compilation, review, and evaluation. In addition, the PCC cooperates in the auditing of major cases of abnormalities under the jurisdiction of other Government Procurement Audit Units. In 2005, the number of cases audited by the Central Procurement Audit Unit, the Government Procurement Audit Units of ministries, commissions and administrations, and the Government Procurement Audit Units of local governments are calculated as 790,2520, and 5464 respectively. - 二、積極推動附屬機關較多之部會署報行政院核准設立採購稽核小組,本年度推動新設立財政部採購稽核小組,並自10月 起開始運作。
- 三、於稽核監督過程中,遇有犯罪嫌疑之案件,逐案移請各該管司法機關處理,並加強聯繫,以瞭解其辦理情形及遏止不法;對於違反政府採購法情節重大而涉有貪瀆之案件,副知法務部政風司;就監審檢調機關移交或協查案件,積極配合辦理,就採購專業提供必要之協助。
- 四、依「採購稽核小組績效考核作業要點」 之規定完成部會署及地方政府採購稽核 小組績效考核作業,並就考核結果提出 獎懲建議,期藉由良性競爭,提升稽核 成效。本年度考核結果列為優等之部會 署有國防部、教育部、法務部、經濟 部、交通部、衛生署、海巡署,列為優 等之地方政府有臺北市、高雄市、臺北 縣、桃園縣、臺南縣、臺東縣、基隆 市、新竹市、臺中市,合計16機關,較 93年增加3機關。

- The PCC actively promotes the establishment of Government Procurement Audit Units by ministries commissions, and administrations with relatively many subordinate agencies.
 During this year the Government Procurement Audit Unit of the Ministry of Finance was set up, beginning operations in October
- 3. Whenever suspected cases of illegal behavior are uncovered during the auditing process, they are turned over to the judicial agency with jurisdiction for disposition; in addition, liaison is stepped up with the aim of understanding the status of disposition and of curbing illegal behavior. Serious violations of the Government Procurement Law that involve corruption are reported to the Government Ethics Department of the Ministry of Justice. The PCC also cooperates actively in cases referred by monitoring, supervision, or prosecutorial agencies, and in joint-investigation cases, by providing professional assistance in the field of procurement.
- 4. The 2005 performance of Government Procurement Audit Units of ministries, commissions, and administrations and local governments was evaluated in accordance with the Guidelines for Performance Evaluation of Procurement Surveillance Units, and rewards and punishments based on the results of the evaluations were proposed with the aim of enhancing the effect of auditing through benign competition. Sixteen governments and agencies (three more than in 2004) were given outstanding unit awards in 2005: the Ministry of National Defense, Ministry of Education, Ministry of Justice, Ministry of Economic Affairs, Ministry of Transportation and Communications, Department of Health, Coast Guard Administration, Taipei City Government, Kaohsiung City Government, Taipei County Government, Taoyuan County Government, Tainan County Government, Taitung County Government, Keelung City Government, Hsinchu City Government, and Taichung City Government.
