Legal Affairs

法規委員會除辦理本會法規委員會法制業務外,並兼辦訴願審議委員會及技師懲戒委員會業務。

壹 法規委員會業務

一、組織

法規委員會委員由具有工程、採購、法律等背景之專家及本會高級人員組成,共計12人,辦理本會主管法規、行政規則、解釋函令之審議及相關法制事項。

二、委員會議審議情形

- (一) 法規會94年度計召開委員會議8次。
- (二)委員會議審議本會主管法規及行政規則之制(訂)定修正案,並審查本會主管法規適用疑義。本年度完成審查之法案舉其要者:
- 1. 政府採購法規,提付審查計「採購評選委員會 審議規則第六條之一條文修正案」、「最有利 標評選辦法第二十條條文修正案」、「採購評 選委員會組織準則第八條」、「採購評選委員 會審議規則部分條文修正案」及「押標金保證 金暨其他擔保作業辦法第三十三條之五修正 案」等5案,均已發布施行(生效)。
- 2. 促進民間參與公共建設法規,提付審查計「促進民間參與公共建設法施行細則修正案」(2月23日之修正案)及「民間參與公共建設甄審委員會組織及評審辦法修正案」等2案,均已發布施行(生效)。又「促進民間參與公共建設法施行細則」本年度第2次修正案,已審議完畢提送行政院審查。另有關本法第五十五條第二項、第五條第二項規定等適用疑義案,亦提委員會討論,使促進民間參與公共建設法之適用更周延完整。

In addition to handling its own legal affairs, the PCC's Legal Affairs Committee also handles legal matters for Appeals Review Committee and Professional Engineers Discipline Committee.

I. Operations of Legal Affairs Committee

1. Organization

Legal Affairs Committee is comprised of experts with engineering, procurement, and legal backgrounds, together with high-ranking PCC personnel, and has a total of 12 members. It handles review and other matters related to laws, regulations, administrative rules, and legal interpretations that come under the jurisdiction of the PCC.

2. Status of the Committee's Review Operations

- (1) The Committee held eight meetings during fiscal year 2005.
- (2) The Committee reviews the enactment and revision and laws and administrative rules under PCC jurisdiction, and also examines points of uncertainty about the application of laws and regulations under PCC jurisdiction. Major bills reviewed in 2005 include the following:
- a. Five government procurement laws and regulations were submitted for review: Revision of Article 6-1 of the Rules for Review by Procurement Evaluation Committee, Revision of Article 20 of the Rules for Selection of the Most Advantageous Tender, Article 8 of the Rules Governing the Organization of the Procurement Evaluation Committee, Partial Revision of the Rules for Review by the Procurement Evaluation Committee, and Revision of Article 33-5 of the Rules for Bid Bonds, Guarantee Bonds and Other Guarantees. All have been promulgated and implemented.
- b. The following two bills related to the promotion of private participation in infrastructure projects were submitted for review, and both have been promulgated and implemented: the Feb. 23 Revision of the Enforcement Rules of Law for Promotion of Private Participation in Infrastructure Projects, and Revision of the Regulations Governing the Organization of the Evaluation Committee for Private Participation in Infrastructure Projects, and Review Methods. In addition, the year's second revision of the Enforcement Rules of Law for Promotion of Private Participation in Infrastructure Projects has completed the review process and has been sent to the Executive Yuan for screening. Furthermore, a bill regarding dissenting opinions about the application of paragraph 2, Article 55 and paragraph 2, Article 5 of the Law for Promotion of Private Participation in Infrastructure Projects have been submitted to the committee for discussion with the aim of making the application of the Law more encompassing.
- In regard to laws and regulations governing professional engineers, two bills concerning uncertainties about

3. Status of Legal Operations

The PCC is handling 18 bills designed to make the application of regulations in the Government Procurement Law, Law for Promotion of Private Participation in Infrastructure Projects, and The Law for Professional Engineers, as well as the surveillance of public construction and the control of construction quality, more complete: Revision of the Items for Attention in the Selection of Public Construction Planning and Design Service Companies, Revision of the Instructions for Procurement Evaluation Committees, Revision of the Requirement for Professional Engineers to Submit Forms 1, 2, and 3 when Applying for the Issuance (Alteration, Replacement, or Re-issuance) of Professional Engineer Licenses, Revision of the Guidelines for the Establishment of the Executive Yuan Committee for the Promotion of Private Participation in Infrastructure Projects, Revision of Points 3, 4, and 5, and Attachment 1, of the Principles for the Establishment and Determination of the Scope of Important Infrastructure Projects Under the Law for Promotion of Private Participation in Infrastructure Projects,

本會依技師法第四十四條、技師懲戒及技師懲戒 覆審委員會組織規程第一條之一之規定,設置技 師懲戒委員會,辦理技師違反技師法相關法規之 技師懲戒事宜。委員由具有工程、採購、法律等 背景之專家、學者、機關代表及本會高級人員組 成。

II. Operations of Appeals Review

itting members of the Legal Affairs Committee serve concurrently as members of the Appeals Review Committee, which handles the review of petitions for the PCC. A total of four petitions were accepted during this year; three have been concluded, and the remaining one is under review.

III. Operations of Professional Engineer Discipline

The PCC has established a Professional Engineers Disciplinary Committee (First Grade), in accordance with the provisions of Article 44 of The Law for Professional Engineers and Article 1-1 of the Organizational Regulations of the Professional Engineers Disciplinary Committees (First and Second Grades), to handle the disciplining of engineers who violate the stipulations of The Law for Professional Engineers. The membership of the committee is made up of experts, scholars, representatives of government agencies, and high-ranking PCC personnel with backgrounds in engineering, procurement, and law.
